

# Terms and Conditions

---

De Facto IAS is Civil Service Preparation Institute Located in Delhi. It is owned by DF Education Private Limited (CIN No . **U80904DL2020PTC360196** ). All Students taking admission in any course, unless otherwise provided, are governed by following terms and condition.

## **1. Admission and Material.**

- a. All admission is subject to payment of fees as prescribed for each Courses, Bank failure or wrong account number or other similar event leading to non-payment of fee would not be considered as a valid payment. However, institute will make every effort to student solve the issue relating to payment.
- b. Material Will supplied in the course applicable, only after full payment, not before that.
- c. Any copying of material is strictly prohibited and shall be governed by Para – 3 of this document.
- d. All admission is subject to providing valid information, including but not limited too, nationality, address and photo of the candidate, any divergence or non-fulfillment will lead to cancellation of admission without any right of refund.

## **2. Discipline in the Institute.**

- a. Student shall maintain total discipline in the institute.
- b. No student shall destroy or attempt to destroy property available within institute premises including classroom located at various locations.
- c. Any passing of lewd comment shall be deemed seriously, especially in relation to female candidates.
- d. Disrespect to teacher and other fellow student is unacceptable.
- e. Any violation of above clauses will result into cancellation of admission without any right to refund, in addition student will be liable to any other proceeding as per law.

## **3. Violation of Copyrights.**

- a. All material, handout of any kind, provided in any medium (digital, physical or otherwise) shall be property of Institute.
- b. Any Violation of copy right or unauthorized distribution of any material supplied shall attract provision of para 5 in totality.

#### **4. Right to Publicity**

- a. In Event of student qualifying any stages of exams, institute have right to give due publicity of the same.
- b. Institute reserves the right to publish information student supplied during or in course of candidates study at the institute (ex – Copies, Videos etc.) for publicity referred above.
- c. Student will duly acknowledge such qualification and cooperate with institute in pursuance with such publicity without any remuneration.

#### **5. Refund and Cancellation.**

- a. No Refund is allowed in any course after admission in any case.
- b. Student are advised to go through our YouTube channels, as to access quality of teaching offered by individual teachers taking the respective course before hand or do your independent evaluation
- c. In rare case where refund is allowed is humanitarian ground, to be independently verified by the institute. (Ex – Including Death, Accident etc.)
- d. In case of refund covered under 'c' above, any tax if applicable shall be deducted along with a cancellation fee of 20% (May increase depending on duration of course completed/taught) of the course fee as applicable.
- e. Violating any terms referred in para 1 – 4, will lead to cancellation of admission without any right to refund.

#### **6. Change in Policy.**
